# COMMUNITY LAND MANAGEMENT PLANS

Management plans are in the process of being developed for the Parklands

---

The *Local Government Act 1999* requires Adelaide City Council (ACC) to prepare Community Land Management Plans for all community land, including the Adelaide Parklands.

Council intends to use this legislative requirement as an opportunity to develop a consistent and coherent management program that anticipates future community needs, facilitates effective decision making and encourages sustainable land uses and management practices.

Community Land Management Plans will set out the goals, objectives and criteria for Council authorities to manage community land. As part of its plan preparation Adelaide City Council will provide a range of opportunities for community input to ensure that park management reflects a diverse range of community values.

Key objectives of the Community Land Management Plans include:

- the generation of a common understanding of how the land will be managed
- consistent decision making based on sound policy
- more accountable and consistent administrative processes

- clear general principles which result in responsive and sound policy decisions.

Community consultation will occur in the early stages of the process to ensure that community ideas are reflected in the plans. We will be operating information booths in Rundle Mall, Central Market, Womad and at selected suburban shopping centres. There will also be Park Open Days at a number of locations throughout the Parklands. Details of the open days will be available on the Council's Web site and in the Messenger Press.

Adelaide City Council would appreciate input from members of the Adelaide Parklands Preservation Association and we look forward to meeting with you during the consultation process.

## KENT TOWN HIGH RISE DEFEATED

As reported in previous newsletters, your Committee was active in opposing a proposed high-rise residential development on Dequetteville Terrace, opposite the old Kent Town Brewery site. The proposed 10-storey building was in our opinion an entirely inappropriate development on that site and, moreover, was singularly unattractive in its bulk and form. It would have had a strongly negative impact on Parklands vistas in that area.

Although planning staff of Norwood, Payneham & St Peters Council had recommended development approval, councillors refused development consent (for which we thank them). The developers appealed to the ERDC Court, and APPA was among the many witnesses appearing for Council in that action.

Some extracts from the judgment:

'It would be a massive structure. Its large mass would result in it sitting uncomfortably with all immediately surrounding development, including the Kent Town Brewery complex ...'

'In its relationship with the dwelling on its eastern side we can only say, to use words from seminal urban design texts, that it is "bad mannered" in the extreme ...'

'The proposal would be an overdevelopment of the site. Its scale and mass are well beyond that which is envisaged by the Development Plan.'

'... we conclude that the proposal offends the relevant provisions of the Development Plan to the extent that it should not be approved. The decision of the Council to refuse the proposal was correct and will be upheld ...'

Your Committee is gratified that, on your behalf, we played some part in helping to stop another visual assault on the Parklands. Development is inevitable, but it must be good development and not 'bad mannered' in the extreme'.

# Bush for Life site in Tuttangga

---

Not far from the towering buildings of Adelaide's CBD, small groups of dedicated Trees for Life Inc (TFL) volunteer Bushcarers are down on their hands and knees conserving remnant plant species in the Parklands.

Three Bushcarers work opposite St Andrew's Hospital on South Terrace, while five work in the north Parklands. The sites were chosen in consultation with the appropriate staff of the Adelaide City Council and TFL.

Over the last three years at the Bush for Life site in Tuttangga ('Grass Place', previously Park 17), there have been two main surprises. The first is the remarkably positive response from the public: 168 people from all walks of life have expressed their appreciation and interest in the restoration of our indigenous vegetation. Three visitors have become Bushcarers after seeing the site, and a Tothill Ranges farmer has started to conserve remnant vegetation on her property.

The second surprise, and an inspiration, is the remnant plant species. Within the degraded site of less than half an acre, twenty local, vascular plant species have been identified so far: ten grass species, two lilies and eight herbs including the Pink Garland-lily. Several of these plant species have state and/or regional conservation status. As the competition from weeds for light, space, moisture and nutrients is gradually removed by the trained Bushcarers, using minimum disturbance methods, the regeneration of the grasses and herbs has been spectacular.

The Tuttangga Bush for Life site is in the Grey Box–South Australian Blue Gum Woodland area of the Parklands. In this vegetation association, the Grey Box would have been the dominant species of the uppermost strata. There is not one remnant Grey Box left in the Parklands, probably because of the excellent burning qualities of its wood. The Bushcarers, therefore,

have collected propagules with permission (eg seeds and cuttings) for this and other species from the nearest remnant plants, propagated them and reinstated them at the site where, despite the drought and without irrigation, they are now flourishing.

In future editions of *Parklands News* the beauty and values of our indigenous vegetation and the small fauna species which are now starting to move into the site will be explored.

# The hurt in Hurtle Square

Five significant trees in Hurtle Square will most probably be put to death soon. The people redesigning the square claim that they plan to put in 62 new trees and 8751 additional plants like perennials, bulbs, hedge plants and shrubs. This seems good, except that the five mature trees still will have gone, together with the animal habitats offered by their imperfections. I don't think the possums, parrots and other birds will find the shrubs, hedges and lines of upright trees along the main road very desirable. And, of course, there is the issue of maintenance, water use and rubbish traps created by the 8751 low-growing plants.

The invitation by the Adelaide City Council (ACC) to make submissions regarding the tree removals resulted in nine representations: two 'fully supportive' and seven raising objections (according to the architects managing the square's redesign). Interestingly, the architects 'do not consider that there is any merit in

opening a debate into the tree assessment' (Danvers Schulz Holland Architects Pty Ltd, letter to ACC dated 28.12.03, p 1). The assessment was done to justify removing the five trees and yet the architects are apparently not interested in discussing the very basis for the decision.

In that same letter to ACC the architects go on to say: 'It should also be noted that this approach was clearly outlined and discussed in detail during the community consultation sessions, that were both heavily advertised, and notified to immediate residents via a postal drop. The proposed Masterplan for Hurtle Square signed off by participants in the consultation sessions clearly notes the requirement for tree removal to achieve the project aims' (p 2).

If ever you needed proof that we should be conscientious in watching the press for consultation

announcements and making the effort to respond, this is it. No doubt the architects genuinely believe that they have consulted appropriately and that their actions are endorsed by all interested parties.

The final decision was made on 19 January. The outcome was predictable, and Kyle Penick's summary statement in his submission opposing the removal of one particular tree, rings true: 'Killing this tree will be a nightmare for "The Forest of Dreams"'.
