I am writing to you in my capacity as Presiding Member of Kadaltilla / Park Lands Authority.

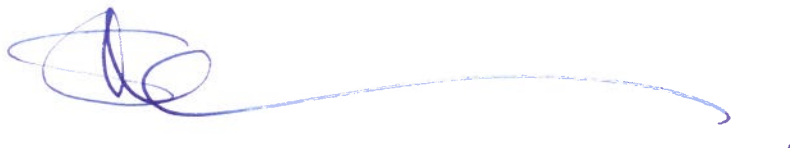
As I know you're aware, the Adelaide Park Lands Authority is the primary advisory body to State and local government on the Adelaide Park Lands and is branded as Kadaltilla / Park Lands Authority.

At the Kadaltilla meeting on 31 March 2022, I raised with Board members my concern about confusion in the community around the identity of the Adelaide Park Lands Authority following a decision by your organisation to rename itself the Adelaide Park Lands Association (APA).

As a result of that discussion, I am formally requesting that APA please add a statement on their website, in a prominent position (ie at the top of the home page), clarifying that the Adelaide Park Lands Association is a community-based organisation distinct from Kadaltilla / Park Lands Authority and is not directly affiliated with the Authority.

## APLA and APA Disambiguation

Thank you for your letter of 8 April 2022 re possible community confusion between the identities and roles of Kadaltilla / Park Lands Authority and the Adelaide Park Lands Association (APA).

I agree it is advisable to reduce the potential for confusion. After hearing from you on the subject at the Authority's meeting on 31 March 2022, I took action to insert a clarifying statement into the footer section of the APA website.

Being in the footer, it is reproduced on every one of the hundreds of pages of our website, so it has more chance of being noticed than if it was placed solely on our home page. The statement includes a link to the Kadaltilla page on the City of Adelaide website. It reads:

DON'T CONFUSE us, the [Adelaide Park Lands Association \(APA\)](#), with [Kadaltilla - the Adelaide Park Lands Authority \(APLA\)](#).

We (APA) are a community-based organisation. We [Explore](#), [Inspire](#), [Protect](#) and [Restore](#).

The Authority (APLA) provides formal advice to the City Council and the State Government on how to manage your Park Lands. The two organisations are not directly connected nor affiliated with each other.

The two organisations are not directly connected nor affiliated with each other, although the 10-member Authority includes one member nominated by APA.
